**NOTES:**

1. Call officials ( teams ) scheduled to be present to officiate your important volleyball game.
2. Call your opponents a) to insure they are going to show up to play volleyball
3. Get to your playing site 10 to 15 minutes early to fill out volleyball score sheet.
4. Make sure all your teammates have their CASE ID Cards at the game site
5. After the contest has concluded, sign volleyball sheet. Make sure officials have also signed the score sheet.
6. If a game needs to be rescheduled, make sure your team, your opponents, your assigned officials have signed the NEW Rescheduling contest agreement form in the IM Office.

**Playing Site:** Veale Center & Horsburgh Gymnasium

**Eligibility:**

All currently enrolled students, faculty/staff at CASE are eligible for volleyball. Each player may be listed on one roster only. Check with the Intramural Office for specific eligibility rules.

Participants should bring their CASE I.D. cards to all intramural contests

**Awards:** Each divisional championship team shall receive a maximum of 10 IM Champ t-shirt.

**Forfeit Policy:** Forfeit time is game time. The intramural staff person present shall declare game time forfeits. Should a team anticipate a forfeit, they should contact Mina Moore at the IM Office.

**Protests:** Only protests regarding player eligibility will be accepted by the IM staff.

**Playoffs:** All teams that meet the following criteria will qualify for their respective divisional playoffs:

1. Does not forfeit any regular season volleyball games.
2. Provides a minimum of two (2) officials per game for all games they are scheduled to officiate.
3. Volleyball official's regular season grade/evaluations from all games assigned and work equals a passing mark.
4. **Officials must have and use their personal whistle to officiate assigned contests.**

**Equipment:** Street shoes are not permitted on the gym floors. All players must wear tennis shoes. All jewelry must be removed before a player is allowed to participate in the game. Game balls and timing devices will be supplied.

**Teams:** Women's and Men's teams consist of six (6) players. A game may be started with as few as five (5) players. A Co-Rec team consists of six (6) players (three (3) females and three (3) males).

A game may be started with as few as five (5) players ((2) males & (3) females).

**Insurance:**

All injuries sustained in intramural play should be reported to the intramural supervisor on duty. Please be aware that neither the Intramural Sports Staff nor Physical Education Department assumes responsibility for injuries sustained while voluntarily participating in Intramural Programs.
